WHEREAS, MILLER COLONY, a Montana Corporation, of Choteau, Montana, is the owner of the following described farm land:

TOWNSHIP 26 NORTH, RANGE 5 WEST Section 31: W2NE4, NW4SE4

and there is an irrigated alfalfa field located in the $W_2^1NE_4^1$ of Section 31, the drainage of which is accomplished by means of a drainage ditch running from the southeast corner of said field along the east property line to a point in the southeast corner of the $NW_4^1SE_4^1$ of said Section 31; and

WHEREAS, IRA E. PERKINS is the owner of farm land immediately adjacent to the east of the above described land; said land being more particularly described as follows:

TOWNSHIP 26 NORTH, RANGE 5 WEST Section 31: E2E2

and he also owns other lands adjacent to the east; and the said IRA E. PERKINS has caused to be constructed a drainage ditch commencing in the southwest corner of the SEASEA of said Section 31 and running in a northeasterly direction across his land to drain into Muddy Creek;

NOW THEREFORE, in consideration of \$1.00, receipt whereof is hereby acknowledged, and the benefits that may derive therefrom, and other good and valuable consideration, said IRA E. PERKINS and EVELYN PERKINS, husband and wife, as Grantors, Parties of the First Part; and MILLER COLONY, a Montana Corporation, as Grantee, Party of the Second Part; have agreed as follows:

That MILLER COLONY will clean out, deepen, dike up as may be necessary, repair and maintain their drainage ditch located on their property in such a manner that none of their surplus water will be persitted to escape the drainage ditch and flood lands of The B.

And in consideration of their so doing, IRA E. PERKINS has agreed that MILLER COLOMY, a Montana Corporation, its successors and assigns forever, may construct, deepen, dike up as necessary, repair and maintain an open ditch or drain ever and across Perkin's said lands, said drainage ditch to be located as follows:

Commencing at a point in the southeast corner of the NwtSEt of said Section 31, where the Miller Colony drainage ditch terminates, and running south along the west line of the EtSEt of said Section 31 to the head of Perkins' drainage ditch which runs into the Muddy Creek as described above;

And PERKINS further agrees that he shall permit the MILLER COLONY to run their excess water into his drainage ditch and that he will permit this excess water to be carried by his drainage ditch into the Muddy Greek.

It is the purpose of this easement to provide the MILLER COLONY with the right to drain surplus water from their irrigated field in such a manner as to sufficiently drain this field without causing any overflow or flooding of irrigation water on the adjacent lands of IRA E. PERKINS.
